My name is RODNEY WILLIAMS and I am giving this statement to Det. Graves of my own free will. I wish to tell Det. Graves what happened on the night of 4-7-93. I left my house about 7:00pm and I went to Boomerangs Theater at Northpark Mall. I met up Danny Villegas and Marcos Gonzalez at the Theater and I was also with Eddie Gonzalez, who goes to Magoffin. I left with Marcos and Danny ; about 9:30pm and Eddie stayed at Boomerangs. We went to the Village Green apartments and we sat on the stairs by my apartment. We sat there for about an hour and a half just talking and then a white car came up with two guys in the car. The guys in the car are nick named Popeye and Snoopy and Popeye was driving. The guys whisited to Danny to go to the car and all three of us went and we cruised around for about thirty minutes. Danny and Marcos wanted to do a beer run and so we went to the Diamond Shamrock and Danny and Marcos made a beer run and got some Budweiser, about a case. I only had one beer and the other guys drank all the beer. We stopped and talked to few girls that I don't know who they were and then Popeye said "let's go do something." I thought that they were going to do another beer run. We drove up Trans Mountain road and we turned off of another road and I don't know the name of it. I saw four guys walking and then Popeye slowed the car and down said something to them in Spanish and I think he said, Que Barrio? I don't understand Spanish, but I have heard people say it before. Two of the guys that were walking came up to the side of the car and started yelling things at the car and I couldn't understand what they said. Popeye drove the car off and we cruised around some streets that I don't know. I heard Popeye and Danny, Marcos, and Snoopy, were all talking in Spanish fast and then after about ten or fifteen minutes Popeye drove the car back to where the guys we had seen were and Popeye then grabbed under the seat and got a gun that was wrapped in a white cloth and he handed the gun to Danny. Danny took the gun and started to fire the gun and one of the guys that was walking fell to the ground right away. Two of the guys started to run right away and then Danny shot the other gun. I think that he hit the other guy in the back. I think that there were four shots fired, but I'm not sure because after the first few shots I covered my ears and bent down behind the seat. I thought that we were getting shot at too. I did not know that

Danny was going to shoot the gun and I couldn't do anything about it. I have seen the two guys that got shot at Boomerangs before, but I didn't know their names. One of the guys used to "cut it up", which means that he could deejay real good. After Danny shot the guys then he wrapped the gun in the cloth it was in and gave it back to Popeye. Popeye put the gun back under the front seat. Popeye was driving the car and Snoopy was sitting beside him in the front passenger seat. Marcos, Me, and Danny, were in the backseat and Marcos was sitting behind the driver, Popeye. I was seated in the middle, and Danny behind the front seat passenger by the door. The car was a white four door car and it was medium sized.

After the shooting the guys started to speak in Spanish again and I didn't understand what they were saying. The guys seemed mad and happy at the same time. Popeye drove me, Marcos, and Danny, to Danny's house and dropped us off at the corner. It was going on 2:00am and we heard some gunshots. We were on the other side of the street from where Danny's house is when the shots happened and we thought that Danny's house got shot at. We went to Danny's house after that and Danny's mom made us get into the house. The cops then came to the house and we talked to them and I asked the cop to give me a ride home. I got a ride home after that. I went to Boomerangs the next day and I saw Marcos there and we walked to Furr's and saw on the newspaper stand that the two guys got killed. The same guys who's pictures were on the front page are the ones that I saw come up to Popeye's car and throw gang signs. I don't know what gang they were from, but Danny, Marcos, Popeye and Snoopy are from VNE gang. Marcos told me to just play the shooting off. I don't have any idea where the gun is now. I have told the truth about who was with us that night and this is all I know. I know what Danny and them did was wrong, but I have been too scared to say anything because I know that they would come back and shoot me.

I HAVE READ THE ABOVE STATEMENT AND FIND IT TO BE TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE.
